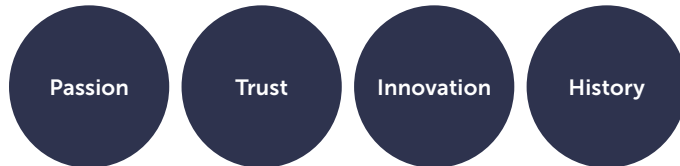

The Maltese flag is not a flag of convenience but is well respected around the world. The registration of yachts under the Maltese flag offers many advantages, including:

- Low company formation and vessel registration costs
- No restrictions on the nationality of the ship owner, captain, officers, and crew
- Tax exemptions or minimal tax obligations
- Possibility of low VAT burden purchasing pleasure yachts
- Commercial vessel operations subject to effective corporate tax rates as low as 5%

Malta Yacht Leasing - Private Clients

For yacht owners seeking an alternative to commercial setups, Malta Yacht Leasing offers a contemporary approach. This model aims to bring clarity and assurance to owners, enabling them to relish their yachts and superyachts while ensuring tranquillity and valuable time with loved ones.

Requirements and Process

The lease agreement involves a Maltese Company (the lessor) and the lessee (the person who leases the yacht). The lessor procures the yacht, intending it for the economic activity of yacht leasing, allowing VAT deduction. Subsequently, the lessor and lessee form a lease agreement for usage. Lease duration isn't restricted, granting flexibility based on individual needs. A thorough evaluation, considering yacht use and specifications, is recommended. VAT, at 18%, applies to monthly/quarterly lease payments.

- A straightforward EU-compliant model, aligned with recent European Court of Justice decisions
- Assured peace of mind for lessees during yacht use and holidays
- Deferral of VAT payment throughout the lease term
- Familiarity of operating leases to Financial Institutions facilitates yacht financing

Malta Tonnage Tax Rules – The Benefits

What is a tonnage tax system?

- A shipping company is liable to pay tonnage tax rather than income tax on the actual profits of the company
- The tonnage tax due is determined on the basis of ship net tonnage, that is on the volume of ships operated by the shipping company
- A number of EU member states, including Malta, the Netherlands, Greece, Portugal, Belgium, Cyprus, Spain and Germany operate some form of tonnage tax system

Malta's Benefits

- An exemption from paying tax on income derived from shipping activities of a shipping organisation or ship manager and on the distribution of profits
- The income, profits or gains of a shipping organisation derived from the sale or other transfer of a tonnage tax ship acquired and sold under the tonnage tax system, or from the disposal of any rights to acquire a ship which when delivered or completed, would qualify as a tonnage tax ship, are exempt from paying tax on the distribution of profits
- An exemption from paying tax on gains arising on the transfer of shares, securities or any other interest held in a shipping organisation to non-Maltese residents (engaged in genuine shipping activities) owning, operating, administering or managing a tonnage tax ship while it was a tonnage tax ship
- An exemption from paying duty on documents and transfers when transferring shares in shipping organisations for non Maltese residents
- An exemption for interests derived from working capital of shipping companies
- A possibility to submit a declaration in lieu of a tax return where the licensed organisation has no income other than shipping activities. In all cases separate accounting must be kept by the shipping organisation and ship manager, clearly distinguishing between shipping activities and other businesses.
